This Amendment No. 1 is being filed jointly by the Reporting Persons and amends the Schedule 13G initially filed by the Reporting Persons with the Securities and Exchange Commission (the “SEC”) on June 4, 2020 (the “Schedule 13G”).

**Item 4. Ownership.**

(a) and (b):

As of the close of business on December 31, 2020, each of the Reporting Persons may have been deemed to have beneficial ownership of 13,694,000 shares of Common Stock, which consisted of (i) 144,000 shares of Common Stock issuable upon exercise of a warrant held by Intracoastal (“Intracoastal Warrant 1”), (ii) 160,000 shares of Common Stock issuable upon exercise of a second warrant held by Intracoastal (“Intracoastal Warrant 2”), (iii) 11,150,000 shares of Common Stock issuable upon exercise of a third warrant held by Intracoastal (“Intracoastal Warrant 3”) and (iv) 2,240,000 shares of Common Stock issuable upon exercise of a fourth warrant held by Intracoastal (“Intracoastal Warrant 4”), and all such shares of Common Stock represented beneficial ownership of approximately 2.4% of the Common Stock, based on (1) 564,051,438 shares of Common Stock outstanding as of November 11, 2020 as reported by the Issuer, plus (2) 144,000 shares of Common Stock issuable upon exercise of Intracoastal Warrant 1, (3) 160,000 shares of Common Stock issuable upon exercise of Intracoastal Warrant 2, (4) 11,150,000 shares of Common Stock issuable upon exercise of Intracoastal Warrant 3 and (5) 2,240,000 shares of Common Stock issuable upon exercise of Intracoastal Warrant 4.
